#### TERMS & DEFINITIONS

**S&P Target Date Through 2035 Index:** The S&P Target Date Through 2035 Index, a subset of the S&P Target Date 2035 Index, has an asset allocation and glide path that aim to be more sensitive to longevity risk at, and beyond, the retirement date. The index is fully investable, with varying levels of exposure to the asset classes determined during an annual survey process of target date funds' holdings.

**Standard & Poor's 500 Composite Index:** S&P 500 Index is a market capitalization-weighted index based on the results of approximately 500 widely held common stocks.
